

## **AUTHOR INSTRUCTIONS**

**Scope of the journal:** The Journal of Aesthetic Dentistry Association of India (ISSN - ) is the official publication of the Aesthetic Dentistry Association of India. This journal publishes original research articles, case reports, short communications, invited reviews (Literature reviews/ Narrative review /Systematic reviews) and comparative studies evaluating materials and methods in the fields of Aesthetic dentistry. This journal will cater to full-time clinicians, full-time academicians, residents, students and scientists. Authors are requested to read the author instructions thoroughly prior to preparation of the manuscript.

**Types of Manuscripts :** Original research articles, Randomised control trials, Comparative studies, Case reports, Short communications, Reviews (Literature/systematic/ narrative) and Letters to editor

**Word Limit :** 2000 words excluding references and abstract. The word limit could be extended to 3500 words (excluding references and abstract) for systematic reviews.

**Title page:** Type of manuscript, The title of the article( concise &informative), Running title or short title not more than 5-6 words.

**Author information:** Name, designation and affiliation of all contributing authors

**Author for correspondence:** Name, address, contact info, email id

**Covering letter**

**Acknowledgment:** Should mention nature of support

**Format:** MS Word (2007 or later)

2. **Manuscript file:** The main text of the article, beginning from Abstract till References (including tables) should be in this file.

**Abstract page:** 150 - 200 word (Background, Aims, Methods and Material, Statistical analysis use, Results and Conclusions) Below the abstract, provide 3 to 10 key words in alphabetical order.

**Introduction:** Should provide sufficient background and pre existing knowledge. Should address the gap in literature (original research articles). The purpose of study, hypothesis and aim must be clearly mentioned.

**Material and Methods**

**Results and statistical analysis**

**Discussion**

**Conclusion**

**References :** References should be numbered consecutively in the order in which they are first mentioned in the text (not in alphabetic order). 15 (max) for a case report and 25 for other original research articles.

**List of tables and figure legends.**

**Language:** British English

**Margin :** 1 inch from all four sides

**Spacing :** All text must be double spaced and justified

3. **Images:** Include only essential figures. All images must be mentioned in the text in the numerical order in which they appear.

**Resolution:** The images should be sent at 300 dpi resolution (.jpeg/ .png/.tiff)

**Size :** 5 inch width

**Legends:** List of legends for the figures/images should be included at the end of the article file. The legend word limit should be 25 words per image

**Ethical Guidelines:**

A statement on ethics committee permission and ethical practices must be included in all research articles under the 'Materials and Methods' section. Evidence for approval by a local Ethics Committee be supplied by the authors on demand. The journal will not consider any paper which is ethically unacceptable

**Protection of Patients' Rights to Privacy:**

Identifying information should not be published in written descriptions, photographs, CBCT scans, etc., and pedigrees unless the information is essential for scientific purposes and the patient (or parent or guardian, wherever applicable) gives informed consent for publication. Authors should remove patients' names from figures unless they have obtained informed consent from the patients. The journal abides by ICMJE guidelines: 1) Authors, not the journals nor the publisher, need to obtain the patient consent form before the publication and have the form properly archived. The consent forms are not to be uploaded with the cover letter or sent through email to editorial or publisher offices. 2) If the manuscript contains patient images that preclude anonymity, or a description that has obvious indication to the identity of the patient, a statement about obtaining informed patient consent should be indicated in the manuscript.

**Manipulation of Digital Photos:**

Digital images submitted should contain the same data as the original image captured. Any manipulation using graphical software is prohibited. Editing should maintain the integrity of photographic images' content and context. For eg. adjustments of brightness, contrast, or color balance must be applied to the whole image and must not amount to misrepresent any information present in the original, including backgrounds. No specific feature within an image may be enhanced, obscured, moved, removed, or introduced. The removal of artifacts in the image is not allowed. Cases of deliberate misrepresentation of data will result in rejection of a manuscript

**Plagiarism prevention:**

All submissions will be subject to a plagiarism check

**Submission of revised manuscript:**

On submission of a revised manuscript after technical modification or peer review, the authors are required to upload a point-to-point reply document in the remarks section. The authors also have to highlight the correction of the queries in a different font colour.
